WHEREAS, the CONG. NATALIO P. CASTILLO SR. MEMORIAL HOSPITAL of the PROVINCIAL GOVERNMENT OF BOHOL made procurement under Purchase Request No. 2022-C-091 re: PROVISION OF ACCOMMODATION AND MEALS DURING THE MONTHLY CHIEF OF HOSPITAL'S MEETING, LIVE-OUT BLS TRAINING & MID-YEAR ASSESSMENT with an ABC of ₱ 154, 000.00;

- c). To recommend for approval by the HONORABLE GOVERNOR of the PROVINCIAL GOVERNMENT OF BOHOL the foregoing findings.


