BAC Resolution Recommending the Use of Negotiated Procurement through Small Value, Declaring Lowest Calculated and Responsive Quotation and Recommending Approval

WHEREAS, the PROVINCIAL PLANNING & DEVELOPMENT OFFICE, of the PROVINCIAL GOVERNMENT OF BOHOL made procurement of goods under Purchase Requests No. 2022-0043, re; Procurement Vehicle Rental for Monitoring, Evaluation & Site Inspection, by the Provincial Planning & Development Office, New Capitol Building, Cogon District, Tagbilaran City, with an ABC of P 97,300.00;

WHEREAS, canvass of prices done in the course of the Negotiated Method of Procurement showed that BOHOL TOURIST MULTI-PURPOSE COOPERATIVE offered the lowest price quotation among the suppliers as reflected in the Abstract of Bid Quotations;
