WHEREAS, the PROVINCIAL PLANNING & DEVELOPMENT OFFICE, of the PROVINCIAL GOVERNMENT OF BOHOL made procurement of goods under Purchase Requests No. 2022-0042, re; Procurement Vehicle Rental for Monitoring, Evaluation o Operation of the Bohol Energy Development Advisory Group (BEDAG), Data Gathering/Validation & Delivery o Communication, by the Provincial Planning & Development Office, New Capitol Building, Cogon District, Tagbilaran City. with an ABC of P 97,300.00;
