**WHEREAS, the PROVINCIAL PLANNING & DEVELOPMENT OFFICE, of the PROVINCIAL GOVERNMENT OF BOHOL made procurement of goods under Purchase Requests No. 2022-0040 re; Procurement Vehicle Rental for Monitoring, Evaluation of Operation of the Bohol Energy Development Advisory Group (BEDAG) Community Based Monitoring System (CBMS), Sustainable Development Goals (SDGS), Data Gathering/Validation & Delivery of Communication, by the Provincial Planning & Development Office, New Capitol Building, Cogon District, Tagbilaran City, with an ABC of P 97,300.00;**


**WHEREAS, canvass of prices done in the course of the Negotiated Method of Procurement showed that BOHOL TOURIST MULTI-PURPOSE COOPERATIVE offered the lowest price quotation among the suppliers as reflected in the Abstract of Bid Quotations;**

**WHEREAS, under Section 53.9 of the IRR of R.A. 9184 and upon careful examination, validation and verification of the accreditation and other pertinent documents of BOHOL TOURIST MULTI-PURPOSE COOPERATIVE, including the price quotation offered, to determine its eligibility to transact business with the Provincial Government and the responsiveness of its quotation BOHOL TOURIST MULTI-PURPOSE COOPERATIVE, has been found to be ELIGIBLE and its bid, RESPONSIVE;**


**NOW, THEREFORE, We, the Members of the Bids and Awards Committee, hereby RESOLVE, as it hereby RESOLVED:**

- c.) To recommend for approval by the **HONORABLE GOVERNOR** of the **PROVINCIAL GOVERNMENT OF BOHOL** the foregoing findings.


