BAC Resolution Recommending the Use of Negotiated Procurement through Small Value, Declaring Lowest Calculated and Responsive Quotation and Recommending Approval

WHEREAS, the **PROVINCIAL PLANNING & DEVELOPMENT OFFICE**, of the **PROVINCIAL GOVERNMENT OF BOHOL** made procurement of goods under Purchase Requests No. **2022-0039**, re; **Procurement Vehicle Rental for Monitoring, Evaluation & Site Inspection, by the Provincial Planning & Development Office, New Capitol Building, Cogon District, Tagbilaran City**, with an ABC of **P 97,300.00**;

WHEREAS, canvass of prices done in the course of the Negotiated Method of Procurement showed that **BOHOL TOURIST MULTI-PURPOSE COOPERATIVE**, offered the lowest price quotation among the suppliers as reflected in the Abstract of Bid Quotations;
