WHEREAS, the OFFICE OF THE PROVINCIAL VETERINARIAN, of the PROVINCIAL GOVERNMENT OF BOHOL made procurement of goods under Purchase Requests No. 2022-0086 re; Procurement of Tires for SJC 462 & D1L453, by the Provincial Veterinarian Office, New Capitol Building, Cogon District, Tagbilaran City, with an ABC of P 110,000.00;

WHEREAS, canvass of prices done in the course of the Negotiated Method of Procurement showed that 200 M AUTO REPAIR SHOP & PARTS offered the lowest price quotation among the suppliers as reflected in the Abstract of Bid Quotations;
