WHEREAS, the OFFICE OF THE PROVINCIAL VETERINARIAN, of the PROVINCIAL GOVERNMENT OF BOHOL made procurement of goods under Purchase Requests No. 2022-0086 re; Procurement of Tires for SJC 462 & D1L453, by the Provincial Veterinarian Office, New Capitol Building, Cogon District, Tagbilaran City. with an ABC of P 110,000.00;
