BAC Resolution Recommending the Use of Negotiated Procurement through Small Value, Declaring Lowest Calculated and Responsive Quotation and Recommending Approval

WHEREAS, the BOHOL DISTRICT JAIL, of the PROVINCIAL GOVERNMENT OF BOHOL made procurement of goods under Purchase Requests No. 2022-0210 re; Procurement of Siphoning of Septage/Sludge, Hauling & Treatment of Septic Tank, by the Bohol District Jail, Cabawan District, Tagbilaran City, Bohol. with an ABC of P 87,500.00;

WHEREAS, canvass of prices done in the course of the Negotiated Method of Procurement showed that ENVIROKONSULT EQUIPMENT & SERVICES INC. offered the lowest price quotation among the suppliers as reflected in the Abstract of Bid Quotations;
