

BAC Resolution Recommending the Use of Negotiated Procurement through Emergency Cases, Declaring Single Calculated and Responsive Quotation and Recommending Approval

WHEREAS, the OFFICE OF THE PROVINCIAL VETERINARIAN of the PROVINCIAL GOVERNMENT OF BOHOL made procurement of goods under Purchase Request No. 2022-0232 re: Procurement of Mineral Block, Molasses & Milk Pail to Support the Dairy Farmers in the Production of Raw Milk, by the Office of the Provincial Veterinarian, Bohol Provincial Capitol, Cogon District, Tagbilaran City, Bohol, with an ABC of P 4,063,200.00;

WHEREAS, canvass of prices done in the course of the Negotiated Method of Procurement showed that LEZAR TRADING offered the lowest price quotation among the suppliers as reflected in the Abstract of Bid Quotations,


NOW, THEREFORE, We, the Members of the Bids and Awards Committee, hereby RESOLVE, as it hereby RESOLVED:
