WHEREAS, the PROVINCIAL HUMAN RESOURCE MANAGEMENT & DEVELOPMENT OFFICE, of the PROVINCIAL GOVERNMENT OF BOHOL made procurement of goods under Purchase Requests No. 2022-0238 re; Procurement Photocopier, by the Provincial Human Resource Management & Development Office, New Capitol Building, Cogon District, Tagbilaran City, with an ABC of P 350,000.00;

NOW, THEREFORE, We, the Members of the Bids and Awards Committee, hereby RESOLVE, as it hereby RESOLVED:






