BAC Resolution Recommending the Use of Negotiated Procurement through Small Value, Declaring Lowest Calculated and Responsive Quotation and Recommending Approval

WHEREAS, the OFFICE OF THE PROVINCIAL SOCIAL WELFARE & DEVELOPMENT, of the PROVINCIAL GOVERNMENT OF BOHOL made procurement of goods under Purchase Requests No. 2022-0246, re; Procurement of Various Spare Parts for Vehicle with plate no. SI Z583 (Fortuner), by the Office of the Provincial Social Welfare & Development, Tamblot Street, Tagbilaran City, Bohol, with an ABC of P 73, 934.00;

WHEREAS, canvass of prices done in the course of the Negotiated Method of Procurement showed that TAGBILARAN CITY TYRE SALES & SERVICE CENTER, offered the lowest price quotation among the suppliers as reflected in the Abstract of Bid Quotations;
