BAC Resolution Recommending the Use of Negotiated Procurement through Small Value, Declaring Lowest Calculated and Responsive Quotation and Recommending Approval

WHEREAS, the OFFICE OF THE VICE GOVERNOR of the PROVINCIAL GOVERNMENT OF BOHOL made procurement of goods under Purchase Request No. 2022-0402 re: Procurement of Envelope & Paper for Use at the Vice Governor's Office Tagbilaran City with an ABC of P 888,537.60

WHEREAS, canvass of prices done in the course of the Negotiated Method of Procurement showed that <u>PRIM E</u> <u>CONSTRUCTION SUPPLIES TRADING</u> offered the lowest calculated and responsive quotation among the suppliers as reflected in the Abstract of Bid Quotations;

WHEREAS, under Section 53.9 of the IRR of R.A. 9184 and upon careful examination, validation and verification of the accreditation and other pertinent documents of <u>PRIM E CONSTRUCTION SUPPLIES TRADING</u> including the price quotation offered, to determine its eligibility to transact business with the Provincial Government and the responsiveness of its quotation, <u>PRIM E CONSTRUCTION SUPPLIES TRADING</u> has been found to be ELIGIBLE and its quotation, RESPONSIVE;

NOW, THEREFORE, We, the Members of the Bids and Awards Committee, hereby RESOLVED:

- a.) To declare <u>PRIM E CONSTRUCTION SUPPLIES TRADING</u> as the bidder with the LOWEST CALCULATED AND RESPONSIVE QUOTATION for the <u>DELIVERY OF GOODS/SERVICES</u> under Negotiated Canvass No.<u>22-0274</u>;
- b.) To recommend award to <u>PRIM E CONSTRUCTION SUPPLIES TRADING</u> for the delivery of goods/services under Negotiated Canvass No.<u>22-0274</u> in the amount of <u>P 886,650.00</u>;
- c.) To recommend for approval by the HONORABLE GOVERNOR of the PROVINCIAL GOVERNMENT OF BOHOL the foregoing findings.
