WHEREAS, the PROVINCIAL PROCUREMENT MANAGEMENT UNIT, of the PROVINCIAL GOVERNMENT OF BOHOL made procurement of goods under Purchase Requests No. 2022-0436, re; Procurement of Various Office Supplies, by the Provincial Procurement Management Unit, New Capitol Building, Cogon District, Tagbilaran City. with an ABC of P 50,605.00;
