

BAC Resolution Recommending Procurement thru Negotiated Method Resulting from the Second Failure of Bidding, Declaring LCRQ and Recommending Award

WHEREAS, the BIDS AND AWARDS COMMITTEE passed BAC Resolution No. 2021-1255 series of 2021 re: BAC Resolution Declaring 2<sup>nd</sup> Failure of Bidding and Recommending Procurement through Negotiated Mode; and was duly approved by the Honorable Governor, authorizing the use of the such Method of Procurement by the PROVINCIAL GOVERNMENT OF BOHOL in undertaking Procurement Request under PR No. 2021-C-181 re: BULK PROCUREMENT OF CATERING SERVICES FOR THE DIFFERENT ACTIVITIES AND EVENTS OF THE PROVINCIAL GOVERNMENT OF BOHOL FOR THE 4<sup>TH</sup> QUARTER OF CY 2021 – D. OTHER ACTIVITIES (PACKED MEALS) with an ABC of ₱ 2, 538, 950.00;

WHEREAS, canvass of prices done in the course of the Negotiated Method of Procurement showed that ALTA CEBU VILLAGE GARDEN RESORT, INC. and REYNA'S THE HAVEN AND GARDENS FOOD CATERING SERVICES, INC. as the lowest calculated and responsive quotation as reflected in the Abstract of Bid Proposals;

WHEREAS, upon careful examination, validation and verification of the accreditation and other pertinent documents, including the price quotation offered, to determine its eligibility to transact business with the provincial government and the responsiveness of its bid and as provided for under paragraph a of Section 53.1 of the Implementing Rules and Regulations of R.A. 9184, ALTA CEBU VILLAGE GARDEN RESORT, INC. and REYNA'S THE HAVEN AND GARDENS FOOD CATERING SERVICES, INC. have been found to be ELIGIBLE and its bid, RESPONSIVE;

NOW, THEREFORE, We, the Members of the Bids and Awards Committee, hereby RESOLVES, as it is hereby RESOLVED:

- a). To declare ALTA CEBU VILLAGE GARDEN RESORT, INC. as the suppliers with the Lowest and Responsive Price Quotation for Item nos. 1, 2, 3, 4 & 6 and REYNA'S THE HAVEN AND GARDENS FOOD CATERING SERVICES, INC. as the suppliers with the Lowest and Responsive Price Quotation for Item no. 5 the Delivery of Catering Services under Negotiated Canvass No. 2021-173 (2<sup>nd</sup> Failure);
- b). To recommend award ALTA CEBU VILLAGE GARDEN RESORT, INC. in the total amount of ₱ 2, 089, 822.00 and REYNA'S THE HAVEN AND GARDENS FOOD CATERING SERVICES, INC. in the total amount of ₱ 403, 521.00 for the delivery of Catering Services under Negotiated Canvass No. 2021-173 (2<sup>nd</sup> Failure);
