WHEREAS the BIDS AND AWARDS COMMITTEE passed BAC Resolution No. _____ series of 2021 re: BAC Resolution Declaring 2nd Failure of Bidding and Recommending Procurement through Negotiated Mode; and was duly approved by the Honorable Governor, authorizing the use of the such Method of Procurement by OFFICE OF THE PROVINCIAL SOCIAL WELFARE & DEVELOPMENT, in undertaking Procurement Request under PR No. 2022-0103, re: Procurement of Various Office Supplies, by the Office of the Provincial Social Welfare & Development, Tamblof Street, Tagbilaran City, Bohol, with an ABC of ₱ 59,653.23;


NOW, THEREFORE, We, the Members of the Bids and Awards Committee, hereby RESOLVES, as it is hereby RESOLVED:



- c). To recommend for approval by the HONORABLE GOVERNOR of the PROVINCIAL GOVERNMENT OF BOHOL the foregoing findings.




