WHEREAS, the OFFICE OF THE SP BOARD MEMBER ALDNER R. DAMALERIO, of the PROVINCIAL GOVERNMENT OF BOHOL made procurement of goods under Purchase Requests No. 2022-0189, re; Procurement of Philippine Flag, by the Office of Board Member Aldner R. Damalerio, New Capitol Compound, Tagbilaran City. with an ABC of P 65,532.00;




