BAC Resolution Recommending the Use of Negotiated Procurement through Small Value, Declaring Lowest Calculated and Responsive Quotation and Recommending Approval

WHEREAS, the PROVINCIAL PLANNING & DEVELOPMENT OFFICE, of the PROVINCIAL GOVERNMENT OF BOHOL made procurement of goods under Purchase Requests No. 2022-0198, re; Procurement Diesel Fuel & Lubricants, by the Provincial Planning & Development Office, New Capitol Building, Cogon District, Tagbilaran City. with an ABC of P 181,500.00;
