WHEREAS, the BIDS AND AWARDS COMMITTEE passed BAC Resolution No. 22-0230-A series of 2021 re: BAC Resolution Declaring 2nd Failure of Bidding and Recommending Procurement through Negotiated Mode; and was duly approved by the Honorable Governor, authorizing the use of the such Method of Procurement by OFFICE OF THE PROVINCIAL AGRICULTURIST in undertaking Procurement Request under PR No. 2022-0100 re; Procurement of Bagging Cellophane & Brown Color Rubberized Pots, by the Office of the Provincial Agriculturist, New Capitol Compound, Tagbilaran City, with an ABC of ₱ 526,500.00;

WHEREAS, canvass of prices done in the course of the Negotiated Method of Procurement showed that LEZAR TRADING offered the lowest price quotation among the suppliers as reflected in the Abstract of Bid Quotation;




NOW, THEREFORE, We, the Members of the Bids and Awards Committee, hereby RESOLVES, as it is hereby RESOLVED:




