



BAC Resolution Recommending the Use of Negotiated Procurement through Small Value, Declaring Lowest Calculated and Responsive Quotation and Recommending Approval

WHEREAS, the **TEODORO B. GALAGAR DISTRICT HOSPITAL, JAGNA, BOHOL**, of the **PROVINCIAL GOVERNMENT OF BOHOL** made procurement of goods under Purchase Requests No. - PHO - 2021 - 348 re: **PROCUREMENT OF VARIOUS MEDICAL SUPPLIES** with an ABC of **P 496,070.00**;



WHEREAS, under Section 53.9 of the IRR of R.A. 9184 and upon careful examination, validation and verification of the accreditation and other pertinent documents of **RGZI MEDICAL AND LABORATORY SUPPLY**, including the price quotation offered, to determine its eligibility to transact business with the Provincial Government and the responsiveness of its bid **RGZI MEDICAL AND LABORATORY SUPPLY**, has been found to be **ELIGIBLE** and its bid, **RESPONSIVE**;


NOW, THEREFORE, We, the Members of the Bids and Awards Committee, hereby **RESOLVE**, as it hereby **RESOLVED**:

- a.) To declare **RGZI MEDICAL AND LABORATORY SUPPLY** as the bidder with the **LOWEST CALCULATED AND RESPONSIVE QUOTATION**, in the amount **P 495,620.00** for the **DELIVERY OF GOODS/SERVICES** under **Negotiated Canvass No. - PHO - 2021 - 273**;
- b.) To recommend award to **RGZI MEDICAL AND LABORATORY SUPPLY** in the amount of **FOUR HUNDRED NINETY FIVE THOUSAND SIX HUNDRED TWENTY PESOS ONLY (P 495,620.00)** for the delivery of goods under **Negotiated Canvass No. - PHO - 2021 - 273**;
- c.) To recommend for approval by the **HONORABLE GOVERNOR** of the **PROVINCIAL GOVERNMENT OF BOHOL** the foregoing findings


