

BAC Resolution Recommending the Use of Negotiated Procurement through Small Value, Declaring Lowest Calculated and Responsive

Quotation and Recommending Approval

RESOLUTION NO. 22 - 11

WHEREAS, the PROVINCIAL HEALTH OFFICE, NEW CAPITOL BUILDING, COGON DISTRICT, TAGBILARAN CITY, of the PROVINCIAL GOVERNMENT OF BOHOL made procurement of goods under Purchase Requests No. - PHO - 2022 - 093 re: PROCUREMENT OF FDA REGISTERED HIV TESTING KIT with an ABC of P 294,000.00;

WHEREAS, canvass of prices done in the course of the Negotiated Method of Procurement showed that IRASETH PHARMACY INC. offered the lowest price quotation among the suppliers as reflected in the Abstract of Bid Proposals,

WHEREAS, under Section 53.9 of the IRR of R.A. 9184 and upon careful examination, validation and verification of the accreditation and other pertinent documents of IRASETH PHARMACY INC. including the price quotation offered, to determine its eligibility to transact business with the Provincial Government and the responsiveness of its bid IRASETH PHARMACY INC. has been found to be ELIGIBLE and its bid, RESPONSIVE;

NOW, THEREFORE, We, the Members of the Bids and Awards Committee, hereby RESOLVE, as it hereby RESOLVED:

- a.) To declare IRASETH PHARMACY INC. as the bidder with the LOWEST CALCULATED AND RESPONSIVE QUOTATION in the amount P 291,900.00 for the DELIVERY OF GOODS/SERVICES under Negotiated Canvass No. – PHO – 2022 – 034;
- b.) To recommend award to IRASETH PHARMACY INC. in the amount of TWO HUNDRED NINETY ONE THOUSAND NINE HUNDRED PESOS ONLY (P 291,900.00) for the delivery of goods under Negotiated Canvass No. PHO 2022 034;
- c.) To recommend for approval by the HONORABLE GOVERNOR of the PROVINCIAL GOVERNMENT OF BOHOL the foregoing findings
