



BAC Resolution Recommending the Use of Negotiated Procurement through Small Value, Declaring Lowest Calculated and Responsive Quotation and Recommending Approval

WHEREAS, the **PROVINCIAL HEALTH OFFICE, NEW CAPITOL BUILDING, COGON DISTRICT, TAGBILARAN CITY**, of the **PROVINCIAL GOVERNMENT OF BOHOL** made procurement of goods under **Purchase Requests No. - PHO - 2022 - 093 re: PROCUREMENT OF FDA REGISTERED HIV TESTING KIT** with an ABC of **P 294,000.00**;


NOW, THEREFORE, We, the Members of the Bids and Awards Committee, hereby **RESOLVE**, as it hereby **RESOLVED**:
