WHEREAS, the **PROVINCIAL HEALTH OFFICE** of the **PROVINCIAL GOVERNMENT OF BOHOL** made procurement under Purchase Request No. **2022-C-136** re: **PROVISION OF MEALS AND SNACKS FOR THE TRAINING ON ESSENTIAL NON-COMMUNICABLE DISEASES INTERVENTIONS TO HEALTH WORKERS, ORIENTATION ON SMOKING CESSATION AND HL PROMOTIONS TO BHWS AND BELLY GOOD TRAINING** with an ABC of **₱ 200, 000.00**;
