WHEREAS, the <u>PROVINCIAL HEALTH OFFICE</u> of the <u>PROVINCIAL GOVERNMENT</u> OF BOHOL made procurement under Purchase Request No. 2022-C-136 re: <u>PROVISION OF MEALS AND SNACKS FOR THE TRAINING ON ESSENTIAL NON-COMMUNICABLE DISEASES INTERVENTIONS TO HEALTH WORKERS, ORIENTATION ON SMOKING CESSATION AND HE PROMOTIONS TO BHWS AND BELLY GOOD TRAINING with an ABC of <u>P 200, 000.00</u>;</u>
