

BAC Resolution Recommending Procurement thru Negotiated Method Resulting from the Second Failure of Bidding, Declaring LCRQ and Recommending Award

WHEREAS, the BIDS AND AWARDS COMMITTEE passed BAC Resolution No. 21-0640-A Series of 2021 re: BAC Resolution Declaring 2<sup>nd</sup> Failure of Bidding and Recommending Procurement through Negotiated Mode; and was duly approved by the Honorable Governor, authorizing the use of the such Method of Procurement by the BOHOL ENVIRONMENT MANAGEMENT OFFICE in undertaking Procurement Request under PR No. 2021-0484 re; Procurement of Laptop for the CRMU Unit, by the Bohol Environment Management Office, Bohol Provincial Capitol Building, Cogon District, Tagbilaran City, Bohol. with an ABC of ₱ 50,000.00;

WHEREAS, canvass of prices done in the course of the Negotiated Method of Procurement showed that PARK AVENUE GENERAL MERCHANDISE offered the lowest price quotation among the suppliers as reflected in the Abstract of Bid Quotation;

- b). To recommend award to PARK AVENUE GENERAL MERCHANDISE or delivery of goods/services under Negotiated Canvass No. 2021-0380 (2nd Failure) in the amount of ₱ 49,900.00;
- c). To recommend for approval by the HONORABLE GOVERNOR of the PROVINCIAL GOVERNMENT OF BOHOL the foregoing findings.
