WHEREAS, the **PROVINCIAL ENGINEER'S OFFICE**, of the PROVINCIAL GOVERNMENT OF BOHOL made procurement of goods under Purchase Requests No. **2022-0199** re; **Procurement of Vehicle Spare Parts with Labor for Mitsubishi Strada with plate no. SKN-820**, by the Provincial Engineer's Office, **New Capitol Compound, Tagbilaran City**, with an ABC of **P 155,688.00**;



NOW, THEREFORE, We, the Members of the Bids and Awards Committee, hereby **RESOLVE**, as it hereby **RESOLVED**:


