BAC Resolution Recommending the Use of Negotiated Procurement through Small Value, Declaring Lowest Calculated and Responsive Quotation and Recommending Approval

RESOLUTION NO. 22 20

WHEREAS, the GARCIA MEMORIAL PROVINCIAL HOSPITAL, TALIBON, BOHOL, of the PROVINCIAL GOVERNMENT OF BOHOL made procurement of goods under <u>Purchase Requests No. - PHO - 2022 - 039</u> re: <u>PROCUREMENT OF LABORATORY SUPPLIES</u> with an ABC of <u>P 278,782.50</u>;

WHEREAS, canvass of prices done in the course of the Negotiated Method of Procurement showed that <u>LABSOLUTION</u> <u>TECHNOLOGIES, INC.</u> offered the lowest price quotation among the suppliers as reflected in the Abstract of Bid Proposals,

WHEREAS, under Section 53.9 of the IRR of R.A. 9184 and upon careful examination, validation and verification of the accreditation and other pertinent documents of <u>LABSOLUTION TECHNOLOGIES</u>, <u>INC.</u> including the price quotation offered, to determine its eligibility to transact business with the Provincial Government and the responsiveness of its bid <u>LABSOLUTION TECHNOLOGIES</u>, <u>INC.</u> has been found to be ELIGIBLE and its bid, RESPONSIVE;

NOW, THEREFORE, We, the Members of the Bids and Awards Committee, hereby RESOLVE, as it hereby RESOLVED:

a.) To declare <u>LABSOLUTION TECHNOLOGIES</u>, <u>INC.</u> as the bidder with the <u>LOWEST CALCULATED AND RESPONSIVE QUOTATION</u> in the amount <u>P 278,230.00</u> for the <u>DELIVERY OF GOODS/SERVICES</u> under <u>Negotiated Canvass No. – PHO – 2022 – 018</u>;

b.) To recommend award to <u>LABSOLUTION TECHNOLOGIES</u>, <u>INC.</u> in the amount of <u>TWO HUNDRED</u> <u>SEVENTY EIGHT THOUSAND TWO HUNDRED THIRTY PESOS ONLY (P 278,230.00)</u> for the delivery of goods under Negotiated Canvass No. – PHO – 2022 - 018;

c.) To recommend for approval by the HONORABLE GOVERNOR of the PROVINCIAL GOVERNMENT OF BOHOL the foregoing findings
