



BAC Resolution Recommending the Use of Negotiated Procurement through Small Value, Declaring Lowest Calculated and Responsive Quotation and Recommending Approval

WHEREAS, the **TEODORO B. GALAGAR DISTRICT HOSPITAL, JAGNA, BOHOL**, of the **PROVINCIAL GOVERNMENT OF BOHOL** made procurement of goods under Purchase Requests No. - PHO - 2022 - 053 re: **PROCUREMENT OF LABORATORY SUPPLIES** with an ABC of **P 316,625.00**;


NOW, THEREFORE, We, the Members of the Bids and Awards Committee, hereby **RESOLVE**, as it hereby **RESOLVED**:




