WHEREAS, the OFFICE OF THE GOVERNOR, of the PROVINCIAL GOVERNMENT OF BOHOL made procurement of goods under Purchase Requests No. 2022-0368 re; Procurement of Spare Parts, by the Office of the Governor, New Capitol Compound, Tagbilaran City. with an ABC of P 51,900.00;

WHEREAS, canvass of prices done in the course of the Negotiated Method of Procurement showed that CARE AUTOHAUS, offered the lowest price quotation among the suppliers as reflected in the Abstract of Bid Quotations;
