**WHEREAS**, the OFFICE OF THE GOVERNOR, of the PROVINCIAL GOVERNMENT OF BOHOL made procurement of goods under Purchase Requests No. 2022-0445 re; Procurement of Various Vehicle Spare Parts with Labor for the Service Vehicle MITSUBISHI/MONTERO (WAGON/SUV) with plate no. BK-2155 by the Office of the Governor, New Capitol Compound, Tagbilaran City, with an ABC of P 95,450.00;
