WHEREAS, the PROVINCIAL GENERAL SERVICES OFFICE, of the PROVINCIAL GOVERNMENT OF BOHOL made procurement of goods under Purchase Requests No. 2022-0148, re; Procurement Batteries for Various Vehicles, by the Provincial General Services Office, New Capitol Building, Cogon District, Tagbilaran City. with an ABC of P 192,000.00;


WHEREAS, canvass of prices done in the course of the Negotiated Method of Procurement showed that TAGBILARAN CITY TYRE SALES & SERVICE CENTER offered the lowest price quotation among the suppliers as reflected in the Abstract of Bid Quotations;
