

BAC Resolution Recommending the Use of Negotiated Procurement through Small Value, Declaring Lowest Calculated and Responsive Quotation and Recommending Approval

WHEREAS, the **PROVINCIAL HEALTH OFFICE, NEW CAPITOL BUILDING, COGON DISTRICT, TAGBILARAN CITY**, of the **PROVINCIAL GOVERNMENT OF BOHOL** made procurement of goods under **Purchase Requests No. - PHO - 2022 - 064** re: **PROCUREMENT OF TIRES, ENGINE OIL, BRAKE FLUID & BATTERIES** with an ABC of **P 204,824.00**;

WHEREAS, canvass of prices done in the course of the Negotiated Method of Procurement showed that **JETS MARKETING** offered the lowest price quotation among the suppliers as reflected in the Abstract of Bid Proposals,


WHEREAS, under Section 53.9 of the IRR of R.A. 9184 and upon careful examination, validation and verification of the accreditation and other pertinent documents of **JETS MARKETING** including the price quotation offered, to determine its eligibility to transact business with the Provincial Government and the responsiveness of its bid **JETS MARKETING** has been found to be **ELIGIBLE** and its bid, **RESPONSIVE**;


NOW, THEREFORE, We, the Members of the Bids and Awards Committee, hereby **RESOLVE**, as it hereby **RESOLVED**:

- b.) To recommend award to **JETS MARKETING** in the amount of **TWO HUNDRED FOUR THOUSAND SIX HUNDRED FOURTEEN PESOS ONLY (P 204,614.00)** for the delivery of goods under **Negotiated Canvass No. - PHO - 2022 - 025**;
- c.) To recommend for approval by the **HONORABLE GOVERNOR** of the **PROVINCIAL GOVERNMENT OF BOHOL** the foregoing findings
