**BAC Resolution Recommending the Use of Negotiated Procurement through Small Value, Declaring Lowest Calculated and Responsive Quotation and Recommending Approval**

WHEREAS, the OFFICE OF THE GOVERNOR, of the PROVINCIAL GOVERNMENT OF BOHOL made procurement of goods under Purchase Requests No. 2022-0146 re; Procurement of Tires, Alternator Pulley & Fan Assembly with Motor for Service Vehicle, by the Office of the Governor, New Capitol Compound, Tagbilaran City, with an ABC of P 395,000.00;

WHEREAS, canvass of prices done in the course of the Negotiated Method of Procurement showed that JETS MARKETING & CARE AUTOHAUS offered the lowest price quotation among the suppliers as reflected in the Abstract of Bid Quotations;

- b.) To recommend award to JETS MARKETING for item nos. 7 & 8 in the amount of P 99,000.00 and CARE AUTOHAUS for item nos. 1 & 2 in the amount of P 144,950.00 for the delivery of goods/services under Negotiated Canvass No. 2022-0085;
- c.) To recommend for approval by the **HONORABLE GOVERNOR** of the **PROVINCIAL GOVERNMENT OF BOHOL** the foregoing findings.
