WHEREAS, upon the conduct of post qualification by the Technical Working Group, EVERYDAY ENTERPRISE, met the required legal, technical and financial requirements for the said project;

WHEREAS, upon recommendation by the Technical Working Group and verification, validation and ascertaining of all statements made and documents submitted by EVERYDAY ENTERPRISE, the bidder declared as the **SINGLE CALCULATED BID**, successfully passed the Post Qualification process, thus the Committee now considered its bid as the **SINGLE CALCULATED and RESPONSIVE BID** for the said project;

NOW THEREFORE, We the Members of the Bids and Awards Committee, hereby RESOLVE, as it is hereby RESOLVED:
