WHEREAS, the **BIDS AND AWARDS COMMITTEE** passed BAC Resolution No. \_\_\_\_\_ series of 2021 re: BAC Resolution Declaring 2nd Failure of Bidding and Recommending Procurement through Negotiated Mode; and was duly approved by the Honorable Governor, authorizing the use of the such Method of Procurement by the **Pres. Carlos P. Garcia Municipal Hospital, Pres. Garcia, Bohol** in undertaking Procurement Request under **PR No. – PHO – 2022 - 048** re: **PROCUREMENT OF I.T. DEVICES & PERIPHERALS TO BE USED IN OFFICE I.T. OPERATIONS (ADMIN, WARD, LABORATORY)** with an ABC of **P 125,100.00**;


WHEREAS, canvass of prices done in the course of the Negotiated Method of Procurement showed that **PARK AVENUE GENERAL MERCHANDISE** offered the lowest price among the suppliers as reflected in the Abstract of Bid Proposals;




NOW, THEREFORE, We, the Members of the Bids and Awards Committee, hereby RESOLVE, as it hereby RESOLVED:

- b. To recommend award **PARK AVENUE GENERAL MERCHANDISE** in the amount of **ONE HUNDRED TWENTY FIVE THOUSAND PESOS ONLY (P 125,000.00)** for the Delivery of Goods under **Negotiated Canvass No. – PHO – 2022 - 054 (2nd failure of bidding)**;
- c. To recommend for approval by the **HONORABLE GOVERNOR** of the **PROVINCIAL GOVERNMENT OF BOHOL** the foregoing findings.




