



BAC Resolution Recommending the Use of Negotiated Procurement through Small Value, Declaring Lowest Calculated and Responsive Quotation and Recommending Approval

WHEREAS, the OFFICE OF THE PROVINCIAL AGRICULTURIST of the PROVINCIAL GOVERNMENT OF BOHOL made procurement of goods under Purchase Requests No. 2021-0115 re; Construction of Rice Mill Shed House Phase 1 at Cabayugan Calape, Bohol, by the Office of the Provincial Agriculturist, Bohol Provincial Capitol, Tagbilaran City, Bohol. with an ABC of P 669,481.46;

WHEREAS, canvass of prices done in the course of the Negotiated Method of Procurement showed that INABANGA DRILLING CONSTRUCTION STEEL FABRICATION & GENERAL MERCHANDISE offered the lowest price quotation among the suppliers as reflected in the Abstract of Bid Quotations;

WHEREAS, under Section 53.9 of the IRR of R.A. 9184 and upon careful examination, validation and verification of the accreditation and other pertinent documents of INABANGA DRILLING CONSTRUCTION STEEL FABRICATION & GENERAL MERCHANDISE including the price quotation offered, to determine its eligibility to transact business with the Provincial Government and the responsiveness of its bid INABANGA DRILLING CONSTRUCTION STEEL FABRICATION & GENERAL MERCHANDISE has been found to be ELIGIBLE and its bid, RESPONSIVE;

NOW, THEREFORE, We, the Members of the Bids and Awards Committee, hereby RESOLVE, as it hereby RESOLVED:

- a.) To declare INABANGA DRILLING CONSTRUCTION STEEL FABRICATION & GENERAL MERCHANDISE as the bidder with the **LOWEST CALCULATED AND RESPONSIVE BID** for the **DELIVERY OF GOODS/SERVICES** under Negotiated Canvass No. 2022-0003 (2ND FAILURE);
- b.) To recommend award to INABANGA DRILLING CONSTRUCTION STEEL FABRICATION & GENERAL MERCHANDISE for the delivery of goods/services under Negotiated Canvass No. 2022-0003 (2ND FAILURE) in the amount of P 665,493.99;
- c.) To recommend for approval by the **HONORABLE GOVERNOR** of the **PROVINCIAL GOVERNMENT OF BOHOL** the foregoing findings.
