WHEREAS, the OFFICE OF THE PROVINCIAL AGRICULTURIST of the PROVINCIAL GOVERNMENT OF BOHOL made procurement of goods under Purchase Requests No. 2021-0115 re; Construction of Rice Mill Shed House Phase 1 at with an ABC of P 669,481.46;

WHEREAS, canvass of prices done in the course of the Negotiated Method of Procurement showed that <u>INABANGA DRILLING</u>
<u>CONSTRUCTION STEEL FABRICATION & GENERAL MERCHANDISE</u> offered the lowest price quotation among the suppliers as reflected in the Abstract of Bid Quotations;
