WHEREAS, the PROVINCIAL MOTOR POOL OFFICE, of the PROVINCIAL GOVERNMENT OF BOHOL made procurement of goods under Purchase Requests No. 2022-0186, re; Procurement of Tires with Tube & Flaps for Road Graders, by the Provincial Motor Pool Office, New Capitol Compound, Tagbilaran City, with an ABC of P 474,000.00;

WHEREAS, canvass of prices done in the course of the Negotiated Method of Procurement showed that CARE AUTOHAUS, offered the lowest price quotation among the suppliers as reflected in the Abstract of Bid Quotations;
