WHEREAS, the PROVINCIAL MOTOR POOL OFFICE of the PROVINCIAL GOVERNMENT OF BOHOL made procurement of goods under Purchase Requests No. 2022-0186, re; Procurement of Tires with Tube & Flaps for Road Graders, by the Provincial Motor Pool Office, New Capitol Compound, Tagbilaran City. with an ABC of P 474,000.00;
