BAC Resolution Recommending the Use of Negotiated Procurement through Small Value, Declaring Lowest Calculated and Responsive Quotation and Recommending Approval

WHEREAS, the PROVINCIAL DISASTER RISK REDUCTION & MANAGEMENT OFFICE, of the PROVINCIAL GOVERNMENT OF BOHOL made procurement of goods under Purchase Requests No. 2022-0301 re; Procurement of Various Vehicle Spare Parts, by the Provincial Disaster Risk Reduction & Management Office, New Capitol Building, Cogon District, Tagbilaran City. with an ABC of P 215,182.00;

WHEREAS, canvass of prices done in the course of the Negotiated Method of Procurement showed that TAGBILARAN CITY TYRE SALES & SERVICE CENTER offered the lowest price quotation among the suppliers as reflected in the Abstract of Bid Quotations;
