## **BAC Resolution Declaring LCRQ and Recommending Award**

WHEREAS, the <u>GOVERNOR'S OFFICE – SPECIAL PROJECTS SECTION</u> of the <u>PROVINCIAL GOVERNMENT OF BOHOL</u> made procurement under Purchase Request No. 2022-C-252 re: <u>PROVISION OF MEALS DURING THE COMMEMORATION OF THE</u> 168<sup>TH</sup> BOHOL DAY CELEBRATION with an ABC of P 345, 000.00;

WHEREAS, canvass of prices done in the course of the Negotiated Method of Procurement showed that <u>PANDA TEA GARDEN</u> <u>SUITES</u> offered the lowest price quotation among the suppliers as reflected in the Abstract of Bids Proposals;
