WHEREAS, the BIDS AND AWARDS COMMITTEE passed BAC Resolution No. 22-0500 series of 2022 re: BAC Resolution Declaring 2nd Failure of Bidding and Recommending Procurement through Negotiated Mode; and was duly approved by the Honorable Governor, authorizing the use of the such Method of Procurement by the **PROVINCIAL HEALTH OFFICE** in undertaking Procurement Request under PR No. 2022-C-130 re: **PROVISION OF MEALS AND SNACKS DURING THE CONDUCT OF NATIONAL VOLUNTARY BLOOD SERVICES PROGRAM** with an ABC of ₱ 431,500.00;
