WHEREAS, the BIDS AND AWARDS COMMITTEE passed BAC Resolution No. 22-0201 Series of 2021 re: BAC Resolution Declaring 2nd Failure of Bidding and Recommending Procurement through Negotiated Mode; and was duly approved by the Honorable Governor, authorizing the use of the such Method of Procurement by **BOHOL PROVINCIAL ENVIRONMENT MANAGEMENT OFFICE** in undertaking Procurement Request under PR No. 2022-0127 re; Procurement of Diesel Fuel, Unleaded Fuel & Engine Oil, by the Bohol Provincial Environment Management Office, New Capitol Building, Tagbilaran City, with an ABC of ₱ 463,125.00;

WHEREAS, canvass of prices done in the course of the Negotiated Method of Procurement showed that **BOHOL PROVINCIAL EMPLOYEES MULTI-PURPOSE COOPERATIVE** offered the lowest price quotation among the suppliers as reflected in the Abstract of Bid Quotation;


WHEREAS, upon careful examination, validation and verification of the accreditation and other pertinent documents, including the price quotation offered, to determine its eligibility to transact business with the provincial government and the responsiveness of its bid and as provided for under paragraph a of Section 53.1 of the Implementing Rules and Regulations of R.A. 9184, **BOHOL PROVINCIAL EMPLOYEES MULTI-PURPOSE COOPERATIVE** has been found to be ELIGIBLE and its quotation, RESPONSIVE;


NOW, THEREFORE, We, the Members of the Bids and Awards Committee, hereby RESOLVES, as it is hereby RESOLVED:



- c). To recommend for approval by the HONORABLE GOVERNOR of the PROVINCIAL GOVERNMENT OF BOHOL the foregoing findings.


