**WHEREAS**, the **BOHOL ENVIRONMENT MANAGEMENT OFFICE**, of the PROVINCIAL GOVERNMENT OF BOHOL made procurement of goods under Purchase Requests No. **2022-0187**, re; **Procurement of Office Supplies, Janitorial Supplies & Ink/Toner, by the Bohol Environment Management Office, New Capitol Compound, Tagbilaran City.** with an ABC of **P 103,472.00**;

**WHEREAS**, canvass of prices done in the course of the Negotiated Method of Procurement showed that **DELMA ENTERPRISE** offered the lowest price quotation among the suppliers as reflected in the Abstract of Bid Quotations;
