WHEREAS, the BOHOL ENVIRONMENT MANAGEMENT OFFICE, of the PROVINCIAL GOVERNMENT OF BOHOL made procurement of goods under Purchase Requests No. 2022-0187, re; Procurement of Office Supplies, Janitorial Supplies & Ink/Toner, by the Bohol Environment Management Office, New Capitol Compound, Tagbilaran City. with an ABC of P 103,472.00;
