

**BAC Recommending Procurement thru Negotiated Method Resulting from the Second Failure of Bidding,  
Declaring LCRQ and Recommending Approval**

**RESOLUTION NO. 202-355  
Series of 2022**

**WHEREAS**, the **BIDS AND AWARDS COMMITTEE** passed BAC Resolution No. \_\_\_\_\_ series of 2018 re: BAC Resolution Declaring 2nd Failure of Bidding and Recommending Procurement through Negotiated Mode; and was duly approved by the Honorable Governor, authorizing the use of the such Method of Procurement by the **GARCIA MEMORIAL PROVINCIAL HOSPITAL, TALIBON, BOHOL** in undertaking Procurement Request under **PR No. – PHO – 2022 – 071** re: **PROCUREMENT OF VARIOUS MEDICAL SUPPLIES** with an ABC of **P 6,071,752.16**;


**WHEREAS**, canvass of prices done in the course of the Negotiated Method of Procurement showed that **DEXTEL TRADING**, offered the lowest price among the suppliers as reflected in the Abstract of Bid Proposals;


**WHEREAS**, upon careful examination, validation and verification of the accreditation and other pertinent documents, including the price quotation offered, to determine its eligibility to transact business with the provincial government and the responsiveness of its bid and as provided for under paragraph a of Section 53 of the implementing Rules and Regulations of R.A. 9184, **DEXTEL TRADING**, has been found to be **ELIGIBLE** and its bid, **RESPONSIVE**;


**NOW, THEREFORE**, We, the Members of the Bids and Awards Committee, hereby **RESOLVE**, as it hereby **RESOLVED**:

- a. To declare **DEXTEL TRADING**, as the supplier with the Lowest and Responsive Price Quotation for the Delivery of Goods under **Negotiated Canvass No. – PHO – 2022 – 106 (2<sup>nd</sup> Failure of Bidding; except for items no. 18, 66, 69 & 77 having no quotation from the suppliers are recommended for re-canvass.**
- b. To recommend award **DEXTEL TRADING**, for the Delivery of Goods under **Negotiated Canvass No. – PHO – 2022 - 106**; in the amount of **FIVE MILLION NINE HUNDRED THIRTEEN THOUSAND EIGHT HUNDRED FIFTEEN PESOS ONLY P 5,913,815.00**;
- c. To recommend for approval by the **HONORABLE GOVERNOR** of the **PROVINCIAL GOVERNMENT OF BOHOL** the foregoing findings.
