WHEREAS, the CONG. NATALIO P. CASTILLO SR. MEMORIAL HOSPITAL, LOON, BOHOL, of the PROVINCIAL GOVERNMENT OF BOHOL made procurement of goods under Purchase Requests No. - PHO - 2022 - 065 re: PROCUREMENT OF VARIOUS JANITORIAL SUPPLIES with an ABC of P 122,679.64;


WHEREAS, canvass of prices done in the course of the Negotiated Method of Procurement showed that DELMA ENTERPRISE offered the lowest price quotation among the suppliers as reflected in the Abstract of Bid Proposals,


WHEREAS, under Section 53.9 of the IRR of R.A. 9184 and upon careful examination, validation and verification of the accreditation and other pertinent documents of DELMA ENTERPRISE including the price quotation offered, to determine its eligibility to transact business with the Provincial Government and the responsiveness of its bid DELMA ENTERPRISE has been found to be ELIGIBLE and its bid, RESPONSIVE;


NOW, THEREFORE, We, the Members of the Bids and Awards Committee, hereby RESOLVE, as it hereby RESOLVED:

- a.) To declare DELMA ENTERPRISE as the bidder with the **LOWEST CALCULATED AND RESPONSIVE QUOTATION** in the amount P 122,590.85 for the **DELIVERY OF GOODS/SERVICES** under Negotiated Canvass No. - PHO - 2022 - 026;
- b.) To recommend award to DELMA ENTERPRISE in the amount of **ONE HUNDRED TWENTY TWO THOUSAND FIVE HUNDRED NINETY PESOS AND 85/100 (P 122,590.85)** for the delivery of goods under Negotiated Canvass No. - PHO - 2022 - 026;
- c.) To recommend for approval by the **HONORABLE GOVERNOR** of the **PROVINCIAL GOVERNMENT OF BOHOL** the foregoing findings
