WHEREAS, the BIDS AND AWARDS COMMITTEE passed BAC Resolution No. 22-0195-A Series of 2021 re: BAC Resolution Declaring 2nd Failure of Bidding and Recommending Procurement through Negotiated Mode; and was duly approved by the Honorable Governor, authorizing the use of the such Method of Procurement by **OFFICE OF THE PROVINCIAL AGRICULTURIST** in undertaking Procurement Request under PR No. 2022-0129, re; Procurement of Compost Fertilizer/Chicken Pure Manure by the Office of the Provincial Agriculturist, New Capitol Compound, Tagbilaran City, with an ABC of ₱ 900,000.00;

WHEREAS, canvass of prices done in the course of the Negotiated Method of Procurement showed that **NOYBIN NURSERY & MARKETING** offered the lowest price quotation among the suppliers as reflected in the Abstract of Bid Quotation;


