**WHEREAS**, the BIDS AND AWARDS COMMITTEE passed BAC Resolution No. 21-0302-A series of 2021 re: BAC Resolution Declaring 2<sup>nd</sup> Failure of Bidding and Recommending Procurement through Negotiated Mode; and was duly approved by the Honorable Governor, authorizing the use of the such Method of Procurement by OFFICE OF THE PROVINCIAL VETERINARIAN in undertaking Procurement Request under PR No. 2022-0185, re: Procurement of CCTV Network Camera Including Installation, by the Office of the Provincial Veterinarian, New Capitol Compound, Tagbilaran City, with an ABC of ₱ 110,000.00;

**WHEREAS**, canvass of prices done in the course of the Negotiated Method of Procurement showed that B AND J COMPUTER SALES AND ELECTRONIC SERVICES INC. offered the lowest price quotation among the suppliers as reflected in the Abstract of Bid Quotation;
