WHEREAS, the GOVERNOR'S OFFICE of the PROVINCIAL GOVERNMENT OF BOHOL made procurement under Purchase Request No. 2022-C-250 re: PROCUREMENT OF ROOM ACCOMODATION ACCOMMODATION AND CATERING SERVICES FOR THE MANAGEMENT EXECUTIVE BOARD (MEB) STRATEGIC PLANNING WORKSHOP with an ABC of P 849, 400.00;
