WHEREAS, the **GOVERNOR'S OFFICE** of the **PROVINCIAL GOVERNMENT OF BOHOL** made procurement under Purchase Request No. **2022-C-250** re: **PROCUREMENT OF ROOM ACCOMODATION ACCOMMODATION AND CATERING SERVICES FOR THE MANAGEMENT EXECUTIVE BOARD (MEB) STRATEGIC PLANNING WORKSHOP** with an ABC of **₱ 849, 400.00**;
